- Students must bring money for lunch at the park on trip day.
- Students may be signed out at the end of the day with Mrs. Brantley and return home with their parents.
- If you are a parent going on this trip, you **MUST** order your ticket through the school to receive the \$34 discounted rate. (Tickets not purchased through the school will cost \$59.99 at the Front Gate.)
- No children in any other grades are allowed on this trip. This is a 5th grade trip only.
